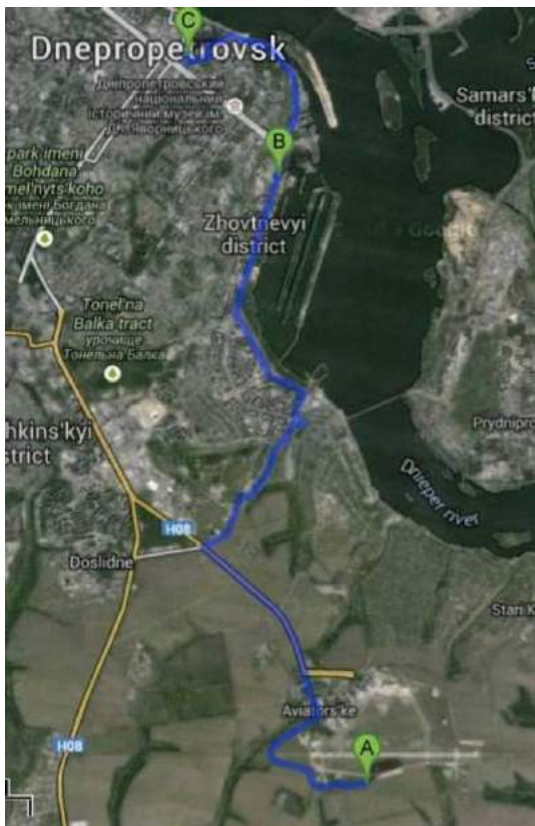

All member Federations **MUST** submit their Intention to Enter for the **2019 IWWF EUROPE UNDER21 WATERSKI CHAMPIONSHIP** through the online Admin system at: <http://iwwfeatc.com/> by **01-06-2019** using the password which was provided to your Federation for this purpose.

For late submission of the Intention to Enter form a penalty of **200,00€** will be applied in accordance with E&A Additional Rules 1.3a.

To be accepted, the "Intention to Enter" form must be accompanied by a deposit amounting to 50,00€ for each athlete mentioned on the form. (For instance: 3 athletes :3x50,00 € = 150,00 €).

Receipt number, must be entered on the form at the time of submission.

This amount is non-refundable. This 50,00 € will be deducted from the entry fee to be paid for each athlete. The Federation may enter up to two additional athletes more than originally declared on the "Intention to Enter" form. If more than two additional athletes participate, then a fee of 50,00 € per additional athlete will be levied upon that Federation.

## **6. OFFICIAL FAMILIARIZATION**

***E&A Tournament Additional Rule 1.18 (Replaces IWWF rule 1.12)***

The last two days immediately before the Championships will be reserved and used for Official Familiarization which is July 31<sup>st</sup> and August 1<sup>st</sup>. This will be organized so that each competitor who has paid shall be allocated either a set number of passes and/or a certain amount of time at the discretion of the Chief Judge based on the principle that every skier shall receive an equal opportunity for familiarization.

Slalom skiers will receive – 4 passes or 6 minutes whichever is less  
Tricks skiers will receive – 2 passes or 5 minutes whichever is less  
Jump skiers will receive – 3 passes or 6 minutes whichever is less

Each team requesting familiarization time shall indicate on the official Intention to Enter form, familiarization is required, which must be submitted at least 60 days before the scheduled start of the event. They must indicate how many skiers in each event wish to participate. Teams who do not comply with this deadline will not be included in the familiarization schedule.

At least 45 days before the scheduled start of the event, the Organizer (in consultation with the Chief Judge, whose decision shall be final) shall announce the official familiarization schedule (including the allowed time). Time will be scheduled for competitors on a random team basis, and shall be grouped by event, i.e. slalom familiarization, trick familiarization and jump familiarization (by jump height) will be grouped together.

Any athlete whose time has not been paid for at least 30 days before the scheduled start of the event, or who is not ready to ski in accordance with the schedule, will lose their official familiarization time.

60 days before	<b>01-06-19</b>	deadline for familiarization requests.
45 days before	<b>17-06-19</b>	deadline for publishing familiarization schedule by Organizer
30 days before	<b>01-07-19</b>	deadline for familiarization payment. Slot will be confirmed through payment.

The Chief Judge shall have the discretion to change the start time of team's familiarization based on extraordinary circumstances.

The Organizer may offer additional training during any unallocated times. The maximum cost per hour for Official familiarization will be € 240,00 (€ 4,00 per minute).

Anyone will be able to book any time remaining available following normal procedure.

4. I acknowledge the authority of IWWF [and its member National Federations and/or National Anti-Doping Organizations] under the IWWF Anti-Doping Rules to enforce, to manage results under, and to impose sanctions in accordance with the IWWF Anti- Doping Rules.
5. I acknowledge and agree that any dispute arising out of a decision made pursuant to the IWWF Anti-Doping Rules, after exhaustion of the process expressly provided for in the IWWF Anti-Doping Rules, may be appealed exclusively as provided in Article [13] of the IWWF Anti-Doping Rules to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport (CAS).
6. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
